Item 5.07 Submission of Matters to a Vote of Security Holders.

(a) 108,542,512 shares of the common stock of Retail Opportunity Investments Corp. (the “Company”) were represented in person or by proxy at the Company’s 2020 Annual Meeting of Stockholders held on April 22, 2020 (the “Annual Meeting”), representing approximately 92.9% of the issued and outstanding shares of the Company’s common stock that were entitled to vote at the Annual Meeting.

(b) At the Annual Meeting, the Company’s stockholders (i) elected the eight directors named below to serve until the Company’s 2021 Annual Meeting of Stockholders; (ii) ratified the appointment of Ernst & Young LLP as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2020; and (iii) approved, on an advisory basis, the compensation of the Company’s named executive officers. The proposals are described in detail in the Company’s proxy statement for the Annual Meeting. The final results for the votes regarding each proposal are set forth below.
